Settlement: Settlement shall be at the conclusion of the auction, each day of the auction. Successful bidders shall be called to remit payment, in order of their registration and bidder number. Bidders shall immediately remove their property, once payment is validated.

Property left at the conclusion of the auction shall become the property of the Colorado Toy Train Group, LLC.

All items are sold AS IS, WHERE IS, without any warranties or refunds. It is the bidders' responsibility to inspect all items prior to bidding.

All sales are final, once the bid is awarded. There are not any refunds, exchanges, or refusals. All disputes are resolved by and at the discretion of the auction chair. The winning bidder and price recorded by the auction clerk on the auction form takes priority, and is official.

The Colorado Toy Train Group, LLC is not responsible for any injuries, loss of property, or damage to personal property. Should any litigation be commenced between the parties to this agreement, the prevailing party shall be entitled to, in addition to such other relief as may be granted, a reasonable sum of attorney's fees for such litigation which shall be determined by the court.

Sales tax shall be collected on all sales from this auction.

Settlement Options: A four percent (4%) buyer's premium shall be added to all sales. Settlement options are either cash or credit card (Discover, Mastercard, or Visa). A four percent (4%) discount shall be given for all cash settlements.
